Membership Terms & Conditions

- Membership is subject to the discretion of the management.
- S&B membership is for a period of 6 months from the date of sign up.
- S&B members are required to show ID on entry to the venue.
- Once the membership period of 6 months has finished, memberships will automatically be put into suspension. During this period the member will not receive any of their benefits. Members will be prompted to renew their membership and if they choose to do so, all benefits will resume. Once the 6 month period has ended, members may re-join S&B membership at any time at the new cost level appropriate.
- S&B membership is non-transferable; and S&B reserves the right to revoke membership at any time.
- Guest Lists - We reserve the right to close guest lists at any point. But not too worry! In this case you will be informed in advance.
- If you pay with a credit card a small transaction fee may be charged. No fee will be charged if you pay with a debit card or cash.
- All payments are non-refundable and non-transferable.
- Re-joining members will have their regular benefits reinstated immediately.
- In the event of any unforeseen circumstances, we reserve the right to cancel any booking made and re-book on an alternative date – subject to availability.
- Members are allowed to be accompanied by one non-member on each visit. Guests must be aged 18 or over
 - Members are to ensure that their guests abide by the rules and regulations of the members club.
 - Members may be allowed more than two guests at one time if prearranged and at the discretion of management.
- Only items purchased within S&B can be consumed in these facilities.
- All bills are to be paid before leaving the premises, any outstanding bills will be charged to members given details
- The management reserve the right to terminate the membership of anyone who behaves or speaks in an offensive manner to a member of staff or another member. In this event refunds will not be applicable.
